Future Shape of Rotherham NHS IT Services

The LMC recently commented on these proposals, in which it is expected that most IT services will in future be provided by RFT. NHS Rotherham do not expect any noticeable changes to the way GP IT is supported and will set up a service level with RFT.

In the meantime, against a background of 45% cuts in management costs over three years, the LMC wish to hear from GPs who encounter any problems regarding the future provision of IT infrastructure or services within primary care.

NHS Appraisal Toolkit

As reported previously, the Department of Health will be allowing their contract with SCHIN, the providers of the NHS Appraisal Toolkit, to expire at the end of October.

The DoH have clarified that up until 31 October 2010, users of the toolkit will be able to their download appraisal documentation from the system in Word (Forms 1-3) and PDF (Form 4) format. Following 31st October 2010 users of the toolkit will still be able to request their data from SCHIN, who will not levy a charge for users to receive their data, irrespective of which appraisal system they have adopted.

However, we also understand that accessing the data will take longer after 31st October as users will need to prove their identity to access their information. We would

therefore advise users of the toolkit to download their appraisal documentation as soon as possible.

The LMC Vice-Chairman has received over a hundred replies from GPs wishing to continue with the electronic system. NHS Rotherham has now been approached with a proposal to extend the use of the system to 31st March 2011 - after which the RCGP toolkit should be **RCGP** available (free to members). decision is Α expected before the end of September.

NHS White Paper

GPs are reminded there is still time to respond to the consultation. The NHS Medical Director will be contacting you shortly to collate a Rotherhamwide response.

The LMC Medical Secretary has recently issued a questionnaire to all GPs asking for your preferred arrangements regarding GP commissioning in Rotherham. Your replies will inform LMC debate on the shape of the local GP consortia.

In the meantime, the GPC continue to produce guidance papers, and on 10th September issued their fourth paper, GP Consortia Commissioning: Latest Observations. This is available to download at: -

National Cleanliness Specifications

The National Patient Safety Agency (NPSA) has now published guidance on cleanliness in the NHS for primary care providers, which is aimed at helping primary care providers set up simple, easy-to-follow processes to ensure that their premises are clean and safe.

Using these specifications is not mandatory, but may be a useful guide for providers and may help towards registration with the Care Quality Commission (CQC) from April 2012.
