#### **Anticoagulation LES**

This has been finalised and unfortunately contains a compulsory training requirement which does not take into account existing skills or training. The PCT tell us this is unavoidable. Practices are advised to ensure that the training will be funded for their practice, along with backfill before agreeing to partake in the LES. We are pushing to have the training provided as part of a PLT but it is not clear this will be possible vet.

#### **Cervical Cytology**

Sheffield Teaching Hospitals NHSFT will commence provision of Cervical Cytology services from 1st April 2010. They have asked us to draw GPs attention to the use of the Open Exeter system in order to strengthen the clinical governance of the service. This will allow GPs to look up the screening history of patients complete electronic request forms for printing locally and attaching samples.

# H1N1 Revised DES Guidance

The GPC has agreed with NHS Employers a revision to the H1N1 DES guidance. This now provides specific details about the process for the calculation of the vaccination uptake figures, which in turn provides for the easement of the patient experience thresholds in the QOF. Pages 7-10 and 16 in the guidance provide the details for this process.

#### **H1N1 Clarification**

Rotherham NHS has been instructed that this programme can continue until the end of September 2010.

Vaccination must continue to be offered to those in highrisk groups and pregnant women. This should be an active process and not opportunistic.

Swine flu vaccine can be offered to those travelling to the Southern hemisphere. The vaccine has been provided free of charge and therefore is free to the patient, however a charge for the administration can be levied on the patient.

#### Neo-natal checks

The LMC have been in discussion with the PCT regarding a small number of requests for GPs to perform new baby checks on babies after home deliveries. This specifically service is excluded from GP contracts. service The is actually commissioned from the acute trust but service provision is good. The LMC considered the matter and felt that although GPs where not obliged to provide the

service we would encourage GPs to do so, if they feel competent, as numbers are likely to be very small.

#### **Pharmacy Guides for GPs**

NHS Employers, the GPC Pharmaceutical and the Services Negotiating Committee (PSNC) have recently produced two guides support **GPs** and community pharmacists in developing more effective working relationships.

(i) The community pharmacy – a guide for general practitioners and practice staff

This guidance covers areas such as funding for arrangements pharmacies, the impact of prescribing policies and the range of clinical and administrative functions that pharmacies community currently provide.

(ii) The GP practice - a guide for community pharmacists and pharmacy staff

This guidance covers areas such funding as arrangements for practices, the impact of QOF. prescribing budgets and policies, and the range of clinical and administrative practices functions that currently provide.

#### **SCR Opt-out**

# Use of premium rate numbers in the NHS

In December 2009 directions to NHS bodies concerning the cost of telephone calls in relation to health services were issued which meant that the use of phone numbers that charge the public or patients a premium rate to contact the NHS were banned in England but that 084 numbers could continue to be used if call charges were no more expensive that those of the equivalent local calls.

From 1<sup>st</sup> April 2010 regulations state that

'The contractor must not enter into, renew or extend a contract as a whole, persons will not pay more to make relevant calls to the practice than they would to make equivalent calls to a geographical number.'

Requests to act on investigations initiated in secondary care. - This was discussed at the last Clinical Board and assurance given that steps were being put in place to stop us being asked to act as community house officers.

Requests from child health to reconcile their vaccination call and recall lists against our clinical systems. - The feels that LMC either practices should run their own call and recall system or the PCT should be using a probably based system, practice clinical around systems, that will not need extra time consuming and prone reconciliation error steps.
