Contract Agreement 2012-13

Changes to the GMS Contract for 2012-13 were announced on 2^{nd} November 2011.

The alterations include:

an agreement not to increase GP pay, in line with NHS doctors other - the piloting of arrangements allow will patients that greater choice of which GP to use - changes to what happens if a patient moves a short distance. allowing many people. where clinically appropriate, to stay in their current GP practice even if they move home - which is important to many patients - the introduction of a new scheme that aims to reduce avoidable Accident and Emergency (A&E) visits. Often patients go to A&E when they could receive excellent and efficient care from their GP instead practice - revisions to the Quality and

Outcomes Framework (QOF), which provides resources for GP practices for delivering excellent care and best practice

MRSA Management

At the last LMC Meeting this issue was discussed with the Chief Medical Officer of Rotherham Hospital FT. Under new proposals our concerns remain that primary care are being asked to swab an excessive number of properative patients for infection.

In the circumstances, we ask GP constituents to report to us cases of pre-operative screening for MRSA so we can assess the impact.

PLT Attendance

In our October newsletter we wrote that the PCT / Clinical Commissioning Group (CCG) have expressed concern about non attendance at PLT by some practitioners.

Following lengthy discussion with the PCT, the following

formula has been agreed, to be applied next year: -

Two-thirds of whole time equivalent practice partners plus salaried GPs who work on a Thursday to attend for each session for which cover is accepted, to be taken over a 12 month period commencing January 2012.

Day of Action 30th November 2011

A day of action to defend public sector pensions against major government reforms is taking place on 30 November. Some unions have balloted members with a view to taking industrial action on the day, whilst others - including the BMA are supporting the dav through campaigning and lobbying activities.
