#### Contract Agreement 2011-12

#### Clinical Waste Pre-Acceptance Audits

The Environment Agency has now re-published its sector guidance 5.07 for operators of waste disposal facilities. The guidance requires all producers of healthcare waste, including GP practices, to complete an audit of their clinical waste. The deadline for this was originally set for October 2010, but was extended due to the need for further consultation with the waste management industry. GP practices must now provide the relevant information to their waste contractor by 1 July 2011.

Practices can either collect the data themselves or employ a third party to do so. Alternatively, the practice's waste contractor may offer to complete the audit but may charge for this service.

The GPC has recently produced a self audit tool and guidance to help practices provide the information themselves if they wish to do so. Copies can be downloaded from the *Publications* section of the LMC website at:

#### **CQC** Registration

CQC have told the GPC that their local compliance officers will be in a position to engage with practices in May/June 2011 once the dentist's registration has finished and the compliance officers have had adequate training.

The Commission will be holding regional events across the UK in June-July 2011 at which they will explain the application for registration process. These events will be open to all GPs.

We realise that there are CQC registration toolkits being produced by commercial companies. The feedback received on the GPC draft toolkit has been positive. #### **GPC** Regional Representative

The LMC would like to take this opportunity to congratulate Dr Trish Edney on her re-election to the post of GPC Regional Representative for the Barnsley, Doncaster, Rotherham and Sheffield region.

#### **Operation Placebo**

This was a 12 month pilot study of the eligibility of foreign nationals by practices for NHS treatment - which came to an end in March 2011. Of 560 applications for eligibility only 280 were accepted – although no data was kept regarding names, numbers of applications and so on.

Woodstock Bower Practice has suggested taking on the vetting process as a further pilot in Rotherham on behalf of other practices. They are currently seeking training advice from the UK Border Agency - which will probably be available in May 2011. The pilot will be funded by the NHS Rotherham. Further details will be available in due course.

## Rotherham LMC Buying Group

All Rotherham GP Practice Managers should have recently received an email communication announcing the launch of the Rotherham LMC Buying Group from 1<sup>st</sup> May 2011. In the midst of the recession, when practices are already suffering the effects of several years without any significant uplift in NHS income, we hope that this will be a welcome, money saving initiative.

### Seasonal Flu Vaccination Programme for 2011/12

The Chief Medical Officer (England) has sent a letter to PCTs and GPs confirming that the arrangements for procurement of vaccines for 2011/12 will remain the same as last year, and urging practices to start ordering their vaccines now, if they have not already done so.

In the letter the government requests that practices order sufficient vaccine to cover 75% of their patients aged 65 or over, and at least 60% of patients under 65 in clinical risk groups (including pregnant women). The GPC has been informed that, so far, practices have not increased their vaccine orders to take into account the localised shortages experienced last winter, and despite a rising number of patients in the at-risk groups.

We would encourage practices to review their flu vaccine orders, to ensure that they have ordered sufficient number of vaccines for their patients in the at-risk groups.

### Taking on New Practice Partners

GP practices may consider a number of different factors when deciding whether to take on a GP partner or salaried GP. To assist practices in this process the GPC has produced guidance Focus on Taking on New Practice Partners.

This guidance looks at:

- the cost of employing a salaried GP, including National Insurance contributions and employer's superannuation;
- the impact of the tax burden for existing partners earning over £100,000;
- the benefits of taking on a new partner.
