LMC Meeting 13th May 2013

At our last meeting, members met Michael Morgan, Interim Executive Chief at Hospital. We Rotherham spoke in particular about handover arrangements for patients discharged into primary care. Mr Morgan was surprised by some of the feedback and offered to hear directly about any particular GP concerns on this subject via the 'Dear Michael: route at: -

TRFT have plans for all midwives to move to entering all data on SystmOne (some midwifes currently use practice EMIS systems), change the way patients

enter the service. standardise communication back to practices about with patients contacts midwifes, midwives taking responsibility bloods for results in pregnancy and consolidation (i.e. reduction) of the number of midwife run clinics across Rotherham. GPC Sessional GPs Subcommittee election

The 2013 election for the GPC Sessional GPs Subcommittee is currently underway. Voting packs were sent out on Tuesday 23 April to all UK locum and salaried GPs, members and nonmembers, who are registered with the BMA database. These packs contain both a hard copy of the ballot and a code that will allow voters the opportunity to complete the ballot online.

If any sessional GPs have not yet received a voting pack, they should contact the BMA Membership Department to update their details. The election closes on 30 May 2013. SO prospective voters must be sure to contact Membership by Tuesday 21 May 2013 at the latest to ensure they have enough time to receive and return a ballot paper.

Changes to Meningitis C Vaccination Programme

The Department of Health (DH) has announced that there will be some changes to the current vaccination schedule for Meningitis C, namely that the second dose, currently given at four months, will be replaced by a booster dose given in adolescence.

The initial change will be to cease giving the four month dose as from 1 June 2013, and from mid-August 2014, there will also be a catch-up programme for first time university entrants under the age of 25 years.
