### LMC Meeting 8th April 2013

At our last meeting, members discussed and gave input into: - the decision to involve a primary care practice in covering twilight hours at the community hospital, shared care bloods and Warfarin monitoring, practices AQPs, the new alcohol LES, GP Quality visits, Suspected DVT Protocol, Dementia Diagnosis Pathway and the backlog of domiciliary visits.

#### **NHS 111**

You may be aware that there has been some debate recently about the responsibility for follow-up of patients after NHS 111 contact.

There has been a meeting between the GPC, the National Clinical advisor for NHS 111, and the Senior Responsible Officer for NHS England and the agreed position is this:

**GPs** would not be responsible for calling back repeat callers who call NHS 111 three times in four days 'within one hour'. Instead, it is expected that all CCGs will commission GPs on behalf of local 111 services to be available to take these calls and provide urgent telephone assessments where Until this necessary. additional capacity has been

commissioned, patients will be responsible for calling their GP within one hour, and practices will be able to use their own standard procedures for determining if patients require an urgent assessment.
