

## Newsletter – March 2017

### LMC Meeting 13h March 2017

At our last LMC meeting we discussed a range of issues, including 2ww referral forms, Quality Contract, referrals to neurology, testosterone therapy prescribing and flu prophylaxis.

### Use of the new medication forms from District Nurses.

GPs are advised there has been no agreement with the LMC regarding the introduction and use of the new medication forms (pink sheets) from District Nurses.

### Breast bisphosphonates.

These can now be claimed as part of DMARDS process.

### Introduction of conference calls for admissions at the Care Co-ordination Centre (CCC)

The LMC feel that these are unnecessary given that the information has already been provided by the GP. Dr Cullen, on behalf of the CCG, confirmed that the process is running in parallel and that time pressured GP's can opt not to participate in a conference call but to pass the details to CCC as previously.

### Dementia LES.

The CCG plan for this year is that the Dementia LES will not be mandatory from April and will only be put into force when the LMC are comfortable with the detail.

### PIP Request Forms.

In the new PIP application form there is a section saying that applicants need to get as much information as possible from their GP to support their claim. This is before the official form is sent to the GP to complete.

LMC advice is that GPs should advise patients to wait until the GP receives the official form, or give patients a summary sheet and not prepare a full report for the PIP as this is subject to charge. See LMC standard letters on our website at

### NHS Property Services

Advice from GPC:-

*We are aware of ongoing issues that practices are experiencing with NHSPS. We are taking action to resolve these issues nationally, but as yet there*

*remain significant unresolved matters which we are dealing with as a matter of urgency. One of the most pressing issues for practices is the increase in service charges. Increases are being levied with seemingly no reference to either*

- i) the contractual arrangements (or lack of such arrangements) that are in place; or*
- ii) the sums historically paid.*

*This allied to the lack of itemised invoicing is making it impossible for practices' to check whether the charges are payable and (to the extent they are) whether they are reasonable and have been properly incurred.*

*In light of these issues, we have met with NHSPS and have highlighted that consideration must be given to a practices' contractual arrangements (or lack thereof) and their historic charges. In addition we have stressed that a robust process needs to be established for both calculating and itemising service charges so as to not only ensure transparency but to ensure that any costs are reasonable and good value for practices.*

*Notwithstanding the above, we are aware that NHSPS are communicating in quite a threatening manner which is causing distress to many practices. Our stance is clear,*

*practices should be satisfied that the charges are duly payable and indeed reasonable before payment is made.*
